Item No. 3: Highlights of NSRIT (24<sup>th</sup> Sept', 2021 – 3<sup>rd</sup> March, 2022)

Member Secretary presented some of the key highlights of the Institution related to the celebration of Alumni Meet, Institute's preparation for NBA accreditation for all four departments, Viz. Mechanical Engineering, Electrical & Electronics Engineering, Electronics & Communication Engineering and Computer Science and Engineering is presented. Induction of Dr. D R Prasada Raju, Former Scientist, DST as a Visiting professor to strengthen the research oriented activities. Suggestions Made

- a. Dr G S N Raju, VC, Centurion University, appreciated the well doing of NSRIT, suggested to strengthen the Examination section with complete measures also suggested to have a clear analysis of results. Further suggested to plan for submission of more project proposals.
- b. To have involvement of 100% faculty in producing research publications as well as in submission of project proposals to statutory bodies.
- c. To enhance quality placements and also to invite good number of organizations to take part in campus recruitment process.

- d. To encourage all young faculty to pursue their PhD program, further Dr. Buddha Singh (UGC Nominee) from JNU New Delhi, given offer to encourage faculty of NSRIT, to have a chance in pursuing Research Program at JNU, New Delhi.
- e. To improve quality teaching and learning process, also to encourage faculty to participate in NPTEL certifications, FDPs organized in ATAL forum.
- f. To improve the academic results of Civil and Mechanical Engineering Students.
- g. To work towards National Institute Ranking Framework (NIRF) in the coming years as this is going to earmark the Institution in the future
- h. To encourage students to involve in outside interactions such as participating in student level competitions such as Hackathons, symposiums, project presentation paper presentation etc. also to encourage students to work on quality projects
- i. To enhance the faculty retention as well as to improve the faculty quality in terms of technical skills and research by enabling them to publish papers in referred journals and submitting quality project proposal to various funding agencies.
